## **“Sussex County Idol” 2018 Official Rules & Regulations**

- You must be a Sussex County resident to participate. All contestants will follow the same rules and regulations.
- Solo vocal performances only (no bands, dancers, etc.).
- There will be no refund of application fee(s) for any reason whatsoever.
- Each contestant must submit the following by September 7, 2017:
  - Completed official entry form.
  - CD and/or YouTube Video link. *Please Note: Contestants must perform the song submitted on the original entry form. Song changes will not be accepted.*
  - Accompaniment cd (instrumental only) for performance (if selected as qualified finalist).
  - Contestant bio.
- IMPORTANT! Contestants will provide own accompaniment on CD (no later than 3 pm on the Thursday prior to event) or sing a cappella. Any contestant not meeting this requirement may not be eligible to perform. Demo and accompaniment cd will not be returned and may be used for promotion of event, possibly in one or more media outlets.
- Length of performance must not exceed 3 minutes.
- Registration will begin at 11:00 a.m. at the Sussex County Idol Pavilion at the Sussex County Fairgrounds. All qualifying contestants must register with event representatives prior to 11:30 a.m. or risk disqualification.
- The Sussex County Chamber of Commerce will determine selection of contestants and placement of performance. Up to 20 finalists, from qualifying entries, will be accepted to perform. Notification of acceptance will be sent out no later than September 10, 2018.
- Attire, lyrics and entertainment must be suitable for a family audience.
- Contestants will be judged on the following criteria, on a scale of 1-10: attire, voice, choreography, command of audience, command of stage, and song selection.
- Performances begin at 12 noon. All contestants must be present throughout the competition.
- Contestants must adhere to all electrical, fire and other codes including county, state or federal.
- Winners will be announced when votes are tallied and must be present to win.
- All decisions are final and will be decided at the discretion of the Sussex County Chamber of Commerce.
